OFFICE REPORT

It is submitted that Mr. Ranbir Singh Yadav, Advocate has filed Special Leave Petition on 02.01.2016 against the Judgment and Order dated 16.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA No. 460, 462, 851, 3277, 8081 of 2014 (O&M) alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution to bring on record the LRs of deceased petitioner no. 18A, 43A and 2A namely Sant Ram in RFA Nos. 460, 8081 and 8668/2014 and petitioner no. 18B and 43B namely Subhash in RFA No.

460 and 8668 of 2014 which is barred by time by 437 and 683 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that originally Special Leave Petition was within time but there is a delay of 38 days in re-filing the Special Leave Petition. Counsel has filed application for condonation of delay in re-filing the SLP.

It is further submitted that notice in SLP (C) No. 2651 of 2016 Entitled Sushila Rani & Anr. Versus State of Haryana & Anr. arising out of common order was directed by the Hon'ble Court on 05.02.2016. SLP is pending after notice (Copy of order dated 05.02.2016 is enclosed herewith).

It is further submitted that SLP (C) No. 6364 of 2016 entitled Mange Ram & Ors. Versus State of Haryana & Anr. arising out of common order was directed to be listed alongwith SLP (C) No. 2651/2016 by the Hon'ble Court on 11.03.2016. (Copy of order dated 11.03.2016 is enclosed herewith)

It is further submitted that Counsel for the petitioner has on 26.07.2016 filed copies of Award in LAC Nos. 1110 & 1259 of 2011 as per his undertaking letter dated 09.03.2016. Copies of the same are being circulated before the Hon'ble Court.

The matter is, therefore, listed before the Hon'ble Court with this office report.
