It is submitted that the above mentioned Special Leave Petition is filed by Mr. Kaushik Poddar, Advocate on 11.04.2016 against the Judgment and Order dated 16.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 5358, 5363, 5365, 6268, 6269, 6270, 6293 of 2013, 1662, 1661/2014, 5356, 5362, 6282-6292/2013, 1655, 1664/2014, 6273-6274/2013, 3615/2014, 5360, 6271/2013, 1660/2014, 6272, 5366/2013, 825,1656, 1659/2014, 5357, 5359, 6275-6281/2013, 8970/2014, 5492, 5493, 9494, 9495, 9361/2013, 3059/2015, 5364/2013, 1664/2014 and 2153/2014 barred by time by 118 days along with the applications for condonation of delay in filing SLP and exemption from filing certified copy of impugned order.

It is further submitted that notice in SLP (C) No. 2651 of 2016 Entitled Sushila Rani & Anr. Versus State of Haryana & Anr. arising out of common followed Judgment

was directed by the Hon'ble Court on 05.02.2016. SLP is pending after notice (Copy of order dated 05.02.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has not furnished copies of notification/documents dated 01.05.2006, 30.04.2007, 07.02.2008, 06.02.2009, 14.08.2008, 22.07.2007, 24.04.2009, 17.01.2014 and 04.03.2013. In this regard, Counsel has given a letter (at page no. 359 of the Paper Books) stating therein that the same are not required at this stage of the matter and has requested to ignore the defect at his own risk.

The matter is listed before the Hon'ble Court with this office report.
