OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Devendra Singh, Advocate on 29.02.2016 against the Judgment and Order dated 16.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 6470/2013, 862/2014, 5435, 5443/2013, 9716, 5407, 7690, 5408/2014, 5596, 5451/2013, 9144/2014, 6798/2013, 6067/2014, 7123/2013, 9560, 6063, 5366, 9562/2014, 7908, 6792/2013, 9550, 9551/2014, 4316/2013, 2845, 2843/2014, 6203, 4841, 4840, 6204, 5464/2013, 2313, 2844, 5252, 4243/2014, 5463, 9206, 4843, 6205/2013 and 2842 of 2014.

It is further submitted that SLP filed against the Order dated 16.09.2015 is barred by time by 69 days in RFA Nos. 9551/2014, 7908/2013 and 4316/2012, 71 days in RFA Nos. 9550 & 9560/2014, 75 days in RFA No. 7123, 7908 and 4316/2013, 70 days in RFA Nos. 6067 & 6063/2014, 73 days in RFA Nos. 5435, 5443/2013, 5596, 5451/2013, 6798/2013, 6792/2013, 2313, 7690, 5408 and 5252/2014, 72 days in RFA No. 9716/2014, 76 days in RFA No. 6470/2013, 76 days in RFA No. 4243/2014, 66 days in RFA Nos.

862/2014, 5366, 9562/2014, 2845, 2843/2014, 6203, 4841, 4840, 6204, 5464/2013, 2844/2014, 5463/2013, 6206, 4843, 6205/2013, and 2842 of 2014. Further there is a delay of 30 days in refiling both the SLPs. Thus there is a delay of days and 99, 101, 105, 100, 103, 102, 106, 106 and 96 days respectively in filing and refiling the Special Leave Petition.

It is further submitted that the instant matter is tagged with SLP (C) No. 12468 of 2016 Entitled Smt. Inderwati (since Deceased Through Lrs) Versus State Of Haryana & Ors. as both are arising out of common followed Judgment.

The matter is listed before the Hon'ble Court with this office report.
