It is submitted that Mr. Satya Mitra Garg, Advocate has filed Special Leave Petitions on 04.01.2016 against the Judgment and Order dated 16.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4395, 3927 of 2013(O&M), 6857/2013, 3992, 5302, 4782, 5332, 3728, 3995, 4781, 3991, 6327, 6280, 3994, 3730, 4784, 3729 of 2014 (O&M) and 6342 of 2013 (O&M) alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution to bring on record LRs of deceased petitioner no. 1 namely Daya Kishan in RFA NO. 3729/2014 (O&M) and Petitioner no. 3 namely Farey @ Piyale lal in RFA No. 6342/2013 (O&M)

which are barred by time by 8 and 264 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 16.09.2015 in RFA Nos. 4395, 3927, 6857, 3992 of 2013 (O&M), 5302, 4782, 3728, 3991, 6327, 3730, 3729, 6342 of 2014 (O&M) are barred by time by 18, 17, 19, 20, 17, 19, 17, 19, 13, 15, 13, 17 days respectively and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that notice in SLP (C) No. 2651 of 2016 Entitled Sushila Rani & Anr. Versus State of Haryana & Anr. arising out of common order was directed by the Hon'ble Court on 05.02.2016. SLP is pending (Copy of order dated 05.02.2016 is enclosed herewith).

The matters are listed before the Hon'ble Court with this office report.
