It is submitted that the above mentioned Special Leave Petition is filed by Mr. Satya Mitra Garg, Advocate on 04.01.2016 against the Judgment and Order dated 16.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4647 of 2013 (O & M), 4200, 4199, 4422, 6410, 4202, 4215, 6135, 4213, 4387, 4211, 4212, 6408, 6411, 4388 of 2014, 4421 of 2013, 6409 and 9114 of 2014 along with the application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution of

deceased Appellant No. 2 namely Kishan Chand in RFA No.9114 of 2014 (O & M) which is barred by time by 21 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Counsel for petitioner has also filed an application for substitution of deceased Appellant No. 1 namely Daya Krishan in RFA No. 6409 of 2014 (O & M).

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 16.09.2015 in RFA Nos. 4647, 4388, 4211 of 2013 (O & M) are barred by time by 17 days, RFA Nos. 4200, 4199, 6135, 6410 of 2014 (O & M), 4202 & 4421 of 2013 (O & M) are barred by time by 16 days, RFA Nos. 4422, 4213, 4387, 4212, 6408, 9144 & 6411 of 2014 (O & M) are barred by time by 15 days and RFA No. 6409 of 2014 (O & M) is barred by time by 13 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that the instant matter is tagged with SLP (C) No. 3690 of 2016 @ D. No. 896 of 2016 Entitled Raj Singh Versus State Of Haryana as both are arising out of common followed Judgment.
