OFFICE REPORT

It is submitted that Mr. Nischal Kumar Neeraj, Advocate has filed Special Leave Petition on 21.12.2015 against the Judgment and Order dated 16.09.2015 in RFA Nos. 5454/2013 (O&M), 7905/2012 (O&M), 7907, 2848, 4280, 4281, 4650, 4842, 4865, 5437-5440, 5442, 5445-5446, 5449-5450, 5452-5453, 5465-5466, 5600, 5623, 5626-5628, 5630, 6101, 6374, 6376-6377, 6790, 6795-6797, 6799, 7375, 7904, 7906 of 2013 (O&M), 1232, 2263, 2742, 2847, 2849-2851, 3038, 4214, 4389, 5363-5365, 5557, 6940, 7848, 4446 of 2014 (O&M) and order dated 06.10.2015 in RFA Nos. 9110,9153-9154 and 9160-9162 of 2014 (O&M) of the High Court of Punjab and Haryana at Chandigarh alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution of the LRs deceased petitioner no. 1 in RFA No. 5454 of 2013, Petitioner no. 6 in RFA No. 5453/2013, petitioner no. 4 in RFA No. 5628/2013, petitioner no. 6 in RFA No. 6374 & 6376/2013, sole petitioner in RFA No. 6790/2013, Petitioner no. 3 in RFA No. 6797/2013, petitioner no. 4 in RFA No. 7906/2013, Petitioner nos. 1, 5 & 7 in RFA No. 3038/2014 and sole petitioner in RFA No. 9110/2014 which are barred by time by 89, 557, 622, 3, 87, 257, 430, 145, 221, 89 and 305 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 16.09.2015 in RFA No. 6101 of 2013 (O&M) is barred by time by 05 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that the instant matter is tagged with SLP (C) No. 3690 of 2016 Entitled Raj Singh Versus State Of Haryana as both are arising out of common followed Judgment.

It is further submitted that Counsel for the petitioner has not furnished copy of notifications dated 14.08.2008, 30.08.2008, 25.08.2011,.0.04.2007, Award dated 27.08.2010, 22.07.2008, 24.04.2009, 17.01.2014 and order dated 22.02.2014 and 03.09.2014 and exhibits. In this regard, Counsel has given a letter dated 16.01.2016 (at page no. 422 of the Paper Books) stating therein that the same are not relevant to the determination of the issued involved and as such are not being filed, and also all the cases have been filed against the common award dated 30.04.2013 and all the LAC number are not mentioned

in the award. Counsel has requested to process and register the SLP at his own risk.

The matter is listed before the Hon'ble Court with this office report.
