OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Nischal Kumar Neeraj, Advocate on 21.12.2015 against the Judgment and Order dated 16.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 6973, 3926, 5209-5210, 5257, 5260, 6665-6666, 6668 t 6670, 6672 to 6680, 6682-6683, 6685-6689, 6691 to 6693, 6802-6803, 6968, 6970 & 6974 of 2013 (O & M), 1239, 1612-1613, 2164, 2218, 3690, 6716, 7320, 9064, 9094, 9096 and 9111 of 2014 (O & M) along with the application for permission to file SLP.

It is further submitted that Counsel for petitioner has also filed an application for substitution of deceased appellants No. 1 and 2 in RFA No. 6674 of 2013

namely Rattan Lal and Prahlad, sole appellant in RFA No. 6794 of 2013 namely Gian Chand and RFA No. 9111 of 2014 namely Ram Pal which are barred by time by 697, 816, 757 & 305 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 16.09.2015 in RFA No. 3690 of 2014 (O & M) is barred by time by 5 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that the instant matter is tagged with SLP (C) No. 1748 of 2016 Entitled Jai Narain & Anr. Versus Land Acquisition Collector & Anr. as both are arising out of common Judgment Order.

It is further submitted that Counsel for the petitioner has not furnished the copies of notification dated 07.02.2008, 01.05.2006, 06.02.2009 & 14.08.2008, Award dated 22.07.2008, 24.04.2009, 27.08.2010, 17.01.2014, 22.01.2013, 04.02.2011, order dated 04.03.2013 and exhibits dated 22.04.2014. In this regard, counsel has given a letter dated 14.01.2016 (Letter is enclosed in the paper books at page no. 355) stating therein that the same are not necessary and Counsel has requested to register and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
