**O R D E R**

CAD.No.8715/2021

The office report indicates that Ld. Counsel for appellant has already filed affidavit of valuation and deficit court fee.

Service of notice is complete on the sole respondent but no one has entered appearance on his behalf.

Mr.Kunal Chatterji,Ld. Advocate has appeared on behalf of the sole respondent. He seeks and is given four weeks time to file the

vakalatnama and the counter affidavit. After expiry of said period, the matter may be processed for listing before the Hon'ble Court whether vakalatnama and counter affidavit filed or not, as service is already completed on behalf of said respondent.
