OFFICE REPORT

SPECIAL LEAVE TO APPEAL(C) NO. 33095 OF 2011

The matter was listed before the Hon'ble Court on 25th November, 2011, when

Accordingly, show cause notice was issued to the sole respondent. Neither  
A.D. card nor unserved cover containing the notice has been received back from the  
sole respondent.

April, 2012 when the following order was passed:-
