Respondent no.3 is granted four weeks time for filing counter affidavit.

Opportunity to respondent nos. 1 and 2 to file counter affidavit has already been declined.

SLP(C) No. 23509-23510/2015

Ld. Counsel for the petitioner to take fresh steps to effect service on respondent no.3 within two weeks time as last opportunity. Notice thereafter be issued.
