The matters above mentioned have been filed on 27th March, 2015 against the common impugned final Judgment and Order dated 1st December, 2014 passed by the High Court of Madras, Madurai Bench at Madurai in C.R.P. (MD) (PD) Nos. 875 to 877 of 2012.

It is submitted that Counsel for the Petitioner has filed applications for permission to file Special Leave Petition along with exemption from filing Official Translation, permission to file additional documents, for impleadment and condonation of delay in filing SLPs, which are barred by time by 26 days.

It is further submitted that the instant matter and SLP Nos. 11497-11499 of 2015 are arising out of common order.
