UPON hearing the counsel the Court made the following  
O R D E R

IA No. 183367/2022 in Crl.A. No. 1643 of 2019.

By filing the present interlocutory application, the

appellant/applicant has made a prayer for deleting Condition No. 3 in the order dated 25.06.2021, which reads thus:

"3. The appellant/applicant shall leave District Hoogly, West Bengal within a period of two weeks from his arrival in the District and also intimate the local police station of the date of his departure and mode of transport."

Learned senior counsel appearing for the respondent/State submits that the apprehension expressed by the concerned authority is that if the petitioner enters District Hoogly, he may face some problems considering the nature of the offence.

Learned counsel for the appellant/applicant states that considering the age of the applicant, he does not mind in taking a risk as regards the apprehension as expressed by the respondent/State.

Accordingly, we relax Condition No. 3 of the order dated 25.06.2021 at the risk of the appellant/applicant.

Interlocutory Application is, accordingly, disposed of.
