UPON hearing the counsel the Court made the following  
O R D E R

Heard the learned counsel appearing for the parties and considered the Compliance Affidavit filed on behalf of NOIDA/Greater NOIDA. We take up the question of fixation of rate

of interest only.

Vide order dated 10.07.2020, we have ordered the payment as per the MCLR Rate. It has been pointed out by the learned senior counsel appearing on behalf of NOIDA/Greater NOIDA that MCLR rate is applicable with effect from 01.04.2016, and not before that. It has also been pointed out that prior to that, SBAR rate was applicable from 01.01.2010 to 30.06.2010 and thereafter, the rate which was applicable was called the Base Rate (w.e.f. 01.07.2010 to 31.03.2016). The details of the rates have been given in Annexure 1 of the Affidavit.

In the circumstances, since MCLR rate is not available for the entire period and the intention of our order was that the rate chargeable by the Bank has to be paid, we modify the order to the effect that the rate from 01.01.2010 to 30.06.2010 would be SBAR, as specified in Paragraph 1 of Annexure 1 and thereafter, the Base Rate as provided in that paragraph would be applicable with effect from 01.07.2010 till 31.03.2016 and thereafter, MCLR would be applicable with effect from 01.04.2016 onwards, as ordered by this Court.

The order dated 10.07.2020 is modified/clarified to the aforesaid extent.
