UPON hearing the counsel the Court made the following
O R D E R

Mr. Vikramajit Banerjee, learned ASG, has placed on record application of Sbicap Ventures Ltd. with respect to the process for selection of stalled projects for funding of SWAMIH Investment Fund-U and corresponding timeline, which is sponsored by the Government of India and managed by Sbicap Ventures Ltd. Following is the criteria :

- (i) At least 90% of the available FSI/FAR is being developed as Affordable Housing units or Mid-Income Housing units;
- (ii) Is networth positive - value of sold receivables plus unsold inventory is greater than cost to complete construction and to service the investment by the Fund;
- (iii) Has completed at least 3% of the construction and development;

(iv) Requires last mile funding - sufficient to complete construction; and

(v) Is a part of a RERA registered project.

. We request the Receiver to deliberate with the Sbicap Ventures Ltd. and furnish the requisite information. On the requisite information being furnished, the Sbicap Ventures Ltd. to deal with the same within 10 days and to submit its proposal.

. With respect to the sale by MSTC, we have requested Mr. Vikramjit Banerjee, Additional Solicitor General of India, to obtain instructions and to apprise us of the present status of the process of sale, duly supported by affidavit to be filed on behalf of the Authorised Officer by MSTC. Learned Receiver has pointed out that there are certain issues with respect to charges which may be attached to the properties, local taxes, dues etc. Prayer has been made that the intending purchaser not to be saddled with any such burden or dues attached to the property. We request the MSTC and NBCC to specify the local charges and dues etc. attached to the properties so that we can pass appropriate orders in that regard.

In re : sale of assets by MSTC and;

In re : Infusion of funds by banks :

After deliberating with various banks, the Receiver has placed on record/pointed out that the banks have entered into loan agreements with the home buyers directly or through Amrapali, and are by and large ready to disburse the loan amount to each home buyer in terms of payment requirement of NBCC. Let the banks consider the cases. It is also suggested that the banks may be asked to waive off the interest levied on defaults of the builder

and home buyers under the subvention agreement and the home buyers may be held liable on the principal amount by them. The undischarged loan amount loaned to Amrapali by the Banks shall remain an independent charge on the respective units. It is also suggested that the legal proceedings including those in the DRT cheque bounce cases under section 138 of the Negotiable Instruments Act, be withdrawn and closed without levying any legal charges/penalties on the home buyers, considering the situation in which they have been put in the case, and the CIBIL score of home buyers be restored ignoring their EMI defaults. It is further pointed out by the Receiver that the banks be directed to disburse old and new loans as if there is regularisation of all accounts of home buyers and of Amrapali.

. It is also proposed that the EMI for already disbursed principal amount should commence from the date of possession of the allotted flat/villa/apartment or after 3 years from the date of restoration of the loan account category from NPA to normal, whichever is earlier.

. The loan disbursal schedule may be planned in an appropriate way, corresponding to the terms of the project phase drawn by NBCC, or to commence after a period of 12 months from today, whichever is advantageous to the home buyers. It is also submitted by the Receiver that all subvention agreements shall stand converted into uniform loan agreements with home buyers with standard repayment terms. It is also submitted that the loan agreements with home buyers can be executed afresh, wherever necessary, without incurring any duty, levy or statutory charges. The banks shall

ignore any switching of allotments or alternate allotments made by Amrapali differing from initial allotments, and shall disburse the loans to the home buyers concerned on their demand, on such terms/relating to the apartment or unit as may be applied to by the home buyers. That the banks shall study the phase-wise construction proposals of NBCC and schedule their payment plans taking into account demands that may be made by the home buyers, falling in the respective projects, or may extend the loans in one lump sum amount.

Let the banks submit their stand on the aforesaid aspects to this Court and in case they are ready, they are free to disburse the loan based on the aforesaid suggestions made by the Receiver, without approaching this Court.

It is open to the home buyers to approach the respective banks and submit their requirements to the bank's branch concerned.

In re : Deposits by Surekha Family Group of Companies :

It was pointed out by Mr. M.L. Lahoty, learned counsel, that in respect of Surekha Family Group of Companies there is a report of the Forensic Auditors pointing out that a sum of Rs.694.44 crores has been diverted and the same has also been mentioned in the judgment and order dated 23.7.2019. A proposal has been submitted by Surekha Family Group of Companies with respect to liquidation of Rs.167 crores in terms of I.A. No.189314/2019 (Annexure-A) containing details of the assets and total value of assets has been shown to be Rs.208.31 crores, whereas the encumbrance shown is of Rs.34.94 crores and the net amount to be available on sale is Rs.168.97 crores. Let the original title

deeds and other documents, as mentioned in Column 5 of the Annexure-A1 be deposited with the Receiver, within seven days from today.

The Registry is directed to accept part payment from Mr. Shiv Priya and Ms. Sonali Suman.

The words "With respect to category 'A' project it is stated by the learned counsel that a sum of Rs.55.11 Crores is to be disbursed" appearing in page no.29 of the order dated 14.10.2019 be read as "With respect to category 'A' of NPA classification, as per Corporation Bank, just for South Zone a sum of Rs.55.11 Crores is to be disbursed for all the Amrapali Projects".

In re : Construction by NBCC :

. Let the NBCC point out the works undertaken by them, its valuation and additional requirement of funds so that appropriate orders may be passed. NBCC is also authorised, in consultation with the Receiver, to undertake all urgent works such as lift erection, electricity, water connection and other remedial works etc. Funds required in this regard be made available on intimation to be received from the Receiver. We also direct the home buyers or respective RWAs., other vendors of Amrapali Projects not to create any problem during the construction by NBCC and they are directed not to interfere in the work executed by NBCC and any person who may be a bidder or authorised evaluator on behalf of NBCC or MSTC, shall be granted access to the projects concerned without any obstruction so as to work out the details for smooth completion of the projects. Publications of the Receiver and advertisements of

NBCC and MSTC in the newspapers may be at Government rates so as to curb the extra burden on the home buyers for which Receiver is authorised to make an appropriate request.
