UPON hearing the counsel the Court made the following
O R D E R

Pursuant to the directions issued on the last occasion, Status Report has been filed on behalf of the respondent which does not indicate any alarming situation.

However, considering the fact that the petitioner was taken to

All India Institute of Medical Sciences (AIIMS) in the month of July and also in the month of August in connection with certain ailments, we direct as under:

(a) The petitioner shall be entitled to the benefit of interim bail for four weeks so that he can get himself treated at a hospital of his choice and/or can have the opinion of any specialist.

(b) In order to facilitate the exercise, the petitioner shall be produced before the Chief Metropolitan Magistrate¹, Dist. East Shahdara, Delhi, who shall release the petitioner on bail subject to such conditions as the CMM may deem appropriate to impose.

c) It shall be the condition of interim bail that the petitioner shall not in any manner misuse his liberty and shall surrender himself before the CMM on or before expiry of four weeks of his release.

(d) After such surrender, the petitioner shall send back to the prison from where he was taken out and produced before the CMM.

(e) After the order is complied with in all respects, the compliance affidavit shall be placed on record.
