O R D E R

SLP(C) No.9183/2024

Service is complete on respondent nos. 9 and 10 but none has entered appearance.

As per office report, counter affidavit filed by respondent nos.1 to 8 has been notified to be defective. However, it is submitted by the ld. Counsel for respondent nos. 1 to 8 that the said defects have been cured and copy of the counter affidavit has been furnished.
