Opportunity to respondent nos. 1 to 4 to file counter affidavit has already been declined vide order dt.15.11.2021.

Service is complete on respondent nos. 7 to 10 but none has entered appearance on their behalf.

Notices issued in respect of application for deletion in I.A. has been duly served on respondent nos. 5 and 6 but no one has entered appearance on their behalf.

Petitioners were granted final opportunity to take appropriate steps in respect of respondent nos.8 and 9, who have reportedly died; however, no such steps have been taken. Ld. counsel for the petitioner has merely filed spare copies together with an application for condonation of delay, however, they have failed to file any application for substitution and further they have not filed any fresh particulars in that regard, as such, notices could not be issued.
