SLP(C) No. 12106/2020

Respondent nos. 1 to 4 have failed to file their respective counter affidavit despite final opportunity having been granted; as such, further opportunity is declined.

Service is already complete on respondent nos. 7 and 10 but none has entered appearance.

IA No.22327/2021 in SLP(C) No. 12106/2020

Service of notice on application, for deletion of names of respondent nos. 5 and 6, is complete but none has entered appearance.

Service Report in respect of notice to respondent no.8 is awaited.

Ld. Counsel for the petitioner submits that they have ascertained that the address of respondent no.9 is correct and that directions may be issued for issuance of notice on the same address.
