1. Taking into consideration the fact that the appeal has been partially heard by the High Court, learned counsel appearing on behalf of the petitioner seeks permission to withdraw these petitions.

2. Permission, as prayed for, is granted.

3. The special leave petitions are, accordingly, dismissed as withdrawn.

1. During the course of hearing, learned counsel for the petitioner submits that the appeal is listed for hearing before the High Court on 26.07.2022.
