OFFICE REPORT

It is submitted that the above mentioned Special Leave Petitions are filed by Mr. S.L. Aneja, Advocate on 12.08.2016 against the Judgment and Order dated 19.10.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 5822 & 6116 of 2015 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** to bring on record the LR. of deceased Appellant No. 6(i) Viz Satish Kumar in RFA No. 5822 of 2015 which is barred by time by 155 days and Counsel has also filed an application for condonation of delay in filing substitution application and prayer for setting aside abatement.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 163 days in filing the SLP (ii) a delay of 16 days in refiling the SLP. There is a total delay of 179 days in filing and refiling the SLP.

It is further submitted that SLP (C) No. 17167 of 2016 @ CC No. 9126 of 2016 Entitled Raj Kumar & Ors. Versus State of Haryana & Ors. arising out of relied upon Judgment was listed before the Hon'ble Court on 29.06.2016 when the Hon'ble Court was directed to issue of notice. The said SLP is pending after notice.(Copy of order dated 29.06.2016 is enclosed herewith)(Main matter is SLP (C) Nos. 13190-13197 of 2016).

It is further submitted that SLP (C) No. 17596 of 2016 Entitled Santro Devi And Ors. Vs State Of Haryana And Anr arising out of relied upon Judgment was listed before the Hon'ble Court on 01.07.2016 when the Hon'ble Court was directed to issue of notice. The said SLP is pending after notice.(Copy of order dated 01.07.2016 is enclosed herewith).

It is further submitted that SLP (C) Nos. 4337-4350 of 2017 @ CC Nos. 1485-1498 of 2015 Entitled Ishwar Singh And Ors. Etc. Etc. Versus State Of Haryana And Anr. Etc. arising out of relied upon Judgment was listed before the Hon'ble Court on 27.01.2017 when the Hon'ble Court was directed to issue of notice. The said SLP is pending after notice. (Copy of order dated 27.01.2017 is enclosed herewith)(Main matter is SLP (C) No. 13190-197 of 2016)

It is further submitted that Counsel for the petitioner has not furnished the copies of notification dated 17.04.2002, 10.04.2003, Award dated 25.06.2004 and 26.06.2004 mentioned in the impugned order. In this regard, counsel has on 19.12.2016 filed a **letter** (Letter is enclosed) stating therein that the same are not necessary and Counsel has requested to ignore the aforesaid defects regarding undertaking and list the matter at his own risk.

The matters are listed before the Hon'ble Court with this office report.
