It is submitted that show cause notice have been issued to all the three common respondents and Respondent No. 4 in SLP (C) No. 13196 of 2016. Mr. Vishwa Pal Singh,

Advocate has filed Vakalatnama/appearance on behalf of State i.e. respondent Nos. 1 to 3. Counsel for the respondent has also filed counter affidavit on behalf of Respondent Nos. 1 and 2.

It is further submitted that as per tracking report, Respondent no. 4 in SLP(C) No. 13196/2016 is unserved due to "Insufficient Address". Neither A.D. Card nor unserved cover containing notice has been received back from Respondent No. 4 so far.
