OFFICE REPORT

It is submitted that Mr. S.L. Aneja, Advocate has filed Special Leave Petition on 27.06.2016 against the Judgment and Order dated 31.08.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 11, 199, 205, 211, 654, 1745, 1964, 1965, 1966, 1983, 1991, 1992, 1998, 2030, 3035 of 2005 and 3802 of 2006 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution to bring on record the Lrs of deceased petitioner namely Raghubir Singh in RFA NO. 1745/2005, Respondent No. 1 (Meer Singh) in RFA No. 1964/2005, Respondent No. 2 (Narain Singh) in RFA No. 1964/2005, Respondent No. 1 (Bhim Singh) in RFA No. 1991/2005, Respondent No. 2 (Nandi Devi) in RFA No. 2030/2005 and Respondent No. 1 (Umed Singh) in RFA No. 1992/2005 which is barred by time by 95, 2178, 3353,

754, 3558 & 1555 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 31.08.2015 barred by time by 211 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that SLP (C) CC No. 2410-2481 of 2016 entitled Devinder Singh And Ors Etc Etc Versus State Of Haryana And Ors Etc Etc arising out of common is a 1N matter.

It is further submitted that SLP (C) Nos. 13190-13197 of 2016 @ CC Nos. 4210-4217 of 2016 Entitled Daya Nang (D) thr. Lrs & Ors. Etc. etc. Versus State of Haryana & Ors. Etc. etc. arising out of common order was listed before the Hon'ble Court on 13.04.2016, when the Hon'ble Court directed to issue of notice. SLP is pending after notice (Copy of order dated 13.04.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has 16.08.2016 filed a letter stating therein that the notification dated 12.05.1995, 10.05.1996 and award dated 31.01.2005, 24.04.1998 and exhibits mentioned in the impugned order as per his undertaking letter are not necessary. Counsel has requested to ignore the defects regarding undertaking. (Copy of letter is enclosed herewith).

The matter is, therefore, listed before the Hon'ble Court with this office report.
