It is submitted that the above mentioned Special Leave Petition is filed by Mr. R.C. Kaushik, Advocate on 04.05.2016 against the Judgment and Order dated 31.08.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA No. 601 of 2005 barred by time by 153 days along with the application for condonation of delay in filing SLP.

It is further submitted that notice in SLP (C) No. 13190-13197 of 2016 entitled Daya nand (D) Thr. LRs & Ors. Etc. Etc. Versus State of Haryana & Ors. Etc. Etc. arising out of common order was directed by the Hon'ble Court on 13.04.2016. SLP is pending after notice. (copy of order dated 13.04.2016 is enclosed herewith).

It is further submitted that SLP (C) CC No. 6016 of 2016 entitled Satbir And Ors. Versus State Of Haryana And Ors. referred to as listing performa was directed by the Hon'ble Court on 13.04.2016 to be tagged with SLP (C) CC Nos. 4210-4217/2016 (SLP (C) No. 13190-97/2016). Copy of order dated 13.04.2016 is enclosed herewith).

It is further submitted that the interlocutory application nos. 25-39 of 2013 in Civil Appeal Nos.

6837-6851 of 2009 entitled Roop Chand & Anr. Etc Versus State of Haryana & Ors. seeking clarification/modification of the Hon'ble Court's order dated 18.09.2013 (Annexure P-3 at page nos. 63-72 in the Paper Books) were dismissed by the Hon'ble Court on 04.04.2014 (copy of order dated 04.04.2014 is enclosed herewith).

It is further submitted that Counsel for the petitioner has not furnished copies of notification/award/annexure/ Gos letter dated 12.05.1995, 10.05.1996 and 24.04.1998. In this regard, Counsel has given a letter dated 04.05.2016 (at page no. 76 of the Paper Books) stating therein that the same are not necessary and has undertaken to produce them if and when directed by the Hon'ble Court and also has requested to list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
