UPON hearing counsel the Court made the following  
O R D E R

In SLP(C) No.29584/2010, respondent No.5 is yet  
unserved for whom dasti service is already issued. Learned

counsel for the petitioner states that since they are unable  
to confirm service upon respondent No.5, they would like to  
delete such respondent and will file an application for the  
purpose within two weeks.

List such SLP before the Hon'ble Judge in Chambers  
after 23.11.2011, either for adjudication of such application,  
if filed till then or for non-prosecution against such  
unserved respondent.

Nobody is present for the petitioner in SLP(C)  
No.35520/2010 wherein petitioner has failed to take  
appropriate steps to confirm service upon unserved respondent  
Nos.5 and 6 even after order dated 1.8.2011. The matter is  
pending since the year 2010 for confirming service only.

List such SLP before the Hon'ble Judge in Chambers,  
if petitioner fails to take appropriate steps before  
23.11.2011.
