Application for listing in open court is dismissed.

There is delay of 150 days in preferring the instant Review Petitions. The explanation offered in the application seeking condonation of delay is not satisfactory at all.

Even then, we have considered the merits of the matter.

The High Court had found that the petitioner herein could not claim any right to move an application under Section 12 of the Protection of Women from Domestic Violence Act, 2005. Consequently, the order passed by the City Civil and Sessions judge was set aside.

After hearing learned counsel for the petitioner, the Special Leave Petitions were dismissed clarifying that the dismissal would not have any reflection on the pending Civil Suit.

We have gone through the Review Petitions and do not find any error apparent on record to justify interference.

These Review Petitions are, therefore, dismissed on the grounds of delay as well as on merits.
