OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. K.K. Mohan, Advocate on 18.03.2016 against the Judgment and Order dated 02.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA No. 5849 of 2011 (O & M) alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased petitioner namely Ishwar Chander which is barred by time by 550 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Counsel for the

petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 108 days in filing the SLP (ii) a delay of 15 days in refiling the SLP. There is a total delay of 123 days in filing and refiling the SLP.

It is further submitted that **notice** in SLP (C) No.13067 of 2016 @ CC No. 7792 of 2016 Entitled Gurvinder Singh Versus State of Haryana & Ors. arising out of common Order was directed on 29.04.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 29.04.2016 is enclosed herewith).

It is further submitted that **notice** in SLP (C) Nos.246-249 of 2016 Entitled Diwan Chand And Anr Etc. Etc. Versus State Of Haryana And Ors Etc. Etc. arising out of common Order was directed on 08.01.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 08.01.2016 is enclosed herewith)(Main matter is SLP (C) Nos. 36087-36124 of 2015).

It is further submitted that Counsel for the petitioner has not furnished the copies of documents/ Award dated 16.12.2005 and exhibits dated 19.12.2002, 18.12.2003, 27.11.2007. In this regard, counsel has given a **letter** dated 10.05.2016 (Letter is enclosed in paper books at page no.107) stating therein that the same are not necessary and Counsel has requested to register and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
