The matter above mentioned was listed before the Hon'ble Court on 30.03.2015, when the Hon'ble Court was pleased pass the following order:

"Heard.

Mr. Arun Bhardwaj, learned Additional Advocate General of the State of Haryana, submits that the State of Haryana has been wrongly impleaded as party respondent in these proceedings as the case pertains to the State of Punjab.

No one appears for the petitioner.

Keeping in view the submission made at Bar, we direct addition of State of Punjab as party respondent to this special leave petition instead of State of Haryana. The petitioner to amend the cause title accordingly.

Notice shall issue to the newly added respondent-State of Punjab, returnable within six weeks."

It is submitted the in compliance of the Court's Order quoted above, Counsel for the petitioner has on 15.4.2015 filed amended memo of parties impleading 'State of Punjab' as Respondent No. 2 instead of 'State of Haryana'. Copy of the amended memo of parties has been included in the Special Leave Petition Paper Books for kind perusal of the Hon'ble Court.

It is further submitted that Show Cause Notice returnable on 06.07.2015 was issued to newly added respondent No. 2/State of Punjab, through Regd. A.D. Post.

It is submitted that neither A.D. Card nor unserved envelope containing notice has been received back from the newly added respondent No. 2/State of Punjab so far.

It is further submitted that instant matter is an after notice matter and there are two respondents in this matter.

It is further submitted that show-cause notice in respect of Respondent NO. 1 is complete and a letter dated 09.04.2015 has been received from Registrar General of High Court of Punjab and Haryana Respondent No. 1, wherein it has been stated that no counsel has been engaged since no contestable interest of the High Court is involved. Copy of the letter dated 09.04.2015 is enclosed herewith for kind perusal of the Hon'ble Court.

Service of show-cause notice is incomplete in respect of Respondent No. 2/State of Punjab.

The matter above mentioned is listed before the Hon'ble Court with this office report.
