C.A. No. 5517-5519/2022

Respondent no.5 has filed counter affidavit.

Respondent nos. 1, 4,7 to 9, 15 to 17 and 28 have failed to file counter affidavit despite last opportunity having been granted, as such, further opportunity stands declined. However, ld.
