**SLP(C) No. 1404/2014:**

The matter above mentioned was listed before the Hon'ble Court on 31.01.2014 when the Court was pleased to pass the following Order:-

It is submitted that as directed above, show cause notice to all the 21 respondents was issued on 19.02.2014 by regd. A.D. Mrs. Anil Katiyar, Mr. Raj Kumar Mehta, Mr. S.K. Sabharwal and Ms. Lily Thomas, advocates have filed vakalatnama/appearance on behalf of respondent Nos. 1, 3 to 6, 8, 10 to 15 and 17 and 20. A.D. cards duly signed in respect of respondent Nos. 2, 9, 16 and 18 has received but no one has entered appearance so

far. Neither A.D. cards nor unserved cover containing notice has been received in respect of respondent Nos. 7, 19 and 21. Counsel appearing for respondent Nos. 1 and 4, 5, 8, 10 to 15, 17 and 20 have filed counter affidavit and the same have been included in SLP paper books.
