O R D E R

I.A. Nos.59400/2025 and I.A. No. 59584/ 2025  
I.A. No. 59376/ 2025 and I.A. No. 59383/ 2025

1) I.A. Nos.59400 of 2025 for impleadment and I.A. No. 59584 of 2025 for directions are filed by applicant-Mr.Manoj Awasthi and I.A. No. 59376 of 2025 for intervention and I.A. No. 59383 of 2025 for directions are filed by applicant-Mr.Vinay Tiwari.

2) Mr. Rahul Kaushik, learned senior counsel appearing for the applicants, submits that their cases of premature release have been rejected by the orders passed by the State; however, granting three weeks' time to surrender, liberty to challenge the said order may be allowed.

3) Prayer seems to be reasonable. Therefore, I.A. Nos.59400/2025, I.A. No. 59584/ 2025, I.A. No. 59376/ 2025 and I.A. No. 59383/ 2025 stand disposed of. The applicants are granted three weeks' time to surrender and they are at liberty to challenge the said order of rejection of their premature release.

4) Mr. K. Parameshwar, learned *Amicus Curiae* appears along with Mr. P.N. Pandey, DIG, Prisons, State of Uttar Pradesh. Mr. Sandeep Jha, Chief Programmer NIC, has also joined virtually.

5) Upon discussion, it is decided that the State of Uttar Pradesh shall provide a list of dedicated officers who may be in contact with the NIC personnels. Mr. Sandeep Jha shall also appoint a Nodal Officer to have discussion with the dedicated team of the Police Department, thereby software may be developed and its demo may be presented before this Court. Let the list of officers be produced on next date.
