OFFICE REPORT

The matter above mentioned was listed before the Hon'ble Court on 19.09.2015, when the Court was pleased to pass the following Order:

“ Issue notice.

In the meantime, parties shall maintain status quo qua possession, as it exists today.”

Accordingly, show cause notice was issued to both the Respondents on 08.10.2014 through Regd. A.D. Post. Neither A.D. Card nor unserved cover containing the notice has been received back in respect of Respondent No. 2 Unserved covers containing the show cause notice has been received for Respondent No. 1 with no postal remarks.

Thereafter, the matter above mentioned was from time to time before Ld. Registrar Court and lastly listed before the Hon'ble Judge in Chambers on 23.09.2015, when His Lordship was pleased to pass the following Order:

**“Learned counsel for the petitioner states that steps for service of Respondent Nos. 1 & 2 have now been taken.
Registry to verify and proceed further accordingly.”**

It is submitted that Mr. Anil Kumar, counsel for the petitioner has on 22.09.2015 filed 2 sets of spare copies but he has not filed fresh address of Respondent No. 1. Hence notice could not be issued.

It is submitted that Mrs. S. Usha Reddy, counsel has on 12.02.2016 filed Vakalatnama/Appearance on behalf of Respondent No. 1 and 2.

The matter above mentioned was lastly listed before the Ld. Registrar Court on 03.03.2016, when the Court was pleased to pass the following Order:

**“The respondents shall be at liberty to file the counter affidavit within a period of four weeks.
List the matter again on 26.04.2016.”**

It is submitted that counsel for the parties has not filed any document so far.

It is further submitted that service of show cause notice is complete on both the Respondents.

The matter above mentioned with this office report is listed before Ld. Registrar Court.
