O R D E R

Shri Anil Divan, learned Senior Counsel appearing for Jagran Pakashan Limited has raised a preliminary objection to a consideration of the legal submissions formulated by contending that the same raises new questions which travel beyond the ambit of the order passed by this Court in respect of which disobedience has been alleged. Shri Divan has further submitted that such questions cannot be adjudicated in exercise of contempt jurisdiction.
