O R D E R

For reasons we do not consider necessary at present to record the exercise of monitoring the

implementation of the Majithia Wage Board Recommendations on the basis of the reports called for from the Labour Commissioners of different States stand deferred to a later date. Instead, it would be prudent and in fact necessary to decide certain questions of law which now stand formulated and have been submitted to the Court by Shri Colin Gonsalves, learned senior counsel, at the request of the Court.

Copies of the aforesaid legal issues be furnished to all the contesting parties and the same would be heard on 16 th

November, 2016 as the first item of the cause-list.

Once the legal formulations are considered and decided, further orders with regard to the mechanism to implement the Majithia Wage Board Recommendations will follow.

Liberty is granted to file response to the legal questions formulated, as mentioned above, in the course of the week.
