**OFFICE- REPORT**

It is submitted that the contempt petition above-mentioned was listed before the Hon'ble Court on 23.08.2016 along with other connected matters, with office report dated 22.08.2016, when the Court was pleased to pass, *inter alia*, the following Order:

"...The matter be brought to the notice of the Chief Secretary of the State of Uttarakhand. The Chief Secretary shall be furnished with a copy of this order as well as the copy of order issued in respect of the State of Uttar Pradesh to ensure due compliance in the light of the directions of this Court in respect of state of Uttarakhand.

Bailable warrant of arrest be issued to ensure the presence of the Labour Commissioner of the State of Uttarakhand before this Court on 4th October, 2016 at 2:00 p.m. ..."

It is submitted that pursuant to the aforesaid order, certified copy of the order dated 23.08.2016 has been issued to all the concerned authorities/States for information and necessary action. Bailable warrant of arrest was also issued to the Senior Superintendent of Police, Nainital Uttarakhand for due compliance of the aforesaid order. Both certified copy and bailable warrant have been delivered to the concerned authorities as per the tracking information of the postal authorities.

It is further submitted that Ms. Rachana Srivastava, standing counsel for the State of Uttarakhand has on 31.08.2016 filed an application for recall of order dated 23.08.2016 along with vakalatnama and memo of appearance. The said application has been registered as I.A. no. 6 of 2016.

It is lastly submitted that Ms. Rachana Srivastava, Advocate has on 01.09.2016 filed affidavit on behalf of State of Uttarakhand (copy of the same is placed below).

Service of notice is complete.

The application in the Contempt Petition above mentioned is listed before Hon'ble Court with this Office Report.
