UPON hearing the counsel the Court made the following
O R D E R

While keeping these contempt petitions pending
we issue the following directions:

All the State Governments acting through their
respective Chief Secretaries shall, within four weeks
from today, appoint Inspectors under Section 17(b) of
the Working Journalists and Other Newspaper Employees
(Conditions of Service) and Miscellaneous Provisions

Act, 1955 to determine as to whether the dues and
entitlements of all categories of Newspaper Employees
including Journalists under the Majithia Wage Board
award has been implemented in accordance with the terms
thereof. The inspectors appointed by the State
Government will naturally exercise their powers as

provided under the Act and shall submit their report to this Court through the Labour Commissioners of each State indicating the precise findings on the issue indicated above. This will be done within a period of three months from the date of appointment under Section 17(b) of the Act.

The cases will be listed again after receipt of the report as above stated.

All contentions with regard to maintainability of the contempt petitions are kept open.
