The matters above mentioned were listed before the Hon'ble Court on 03.03.2017 with an office report dated 02.03.2017, when the Court was pleased to pass the following order:

SLP No. 15438/2016

It is submitted that there are total 7 Respondents. Counter affidavit on behalf of Respondent Nos. 1-5 & reply on behalf of Respondent No. 7 have been included in the SLP paper books by circulation. Neither A.D. card nor unserved cover, in respect of respondent no. 6, has been received.

Service of show cause notice is not complete on respondent no. 6.

It is further submitted that counsel for the petitioners has on 05.12.2016 and 09.12.2016 filed rejoinder affidavit to the reply affidavit of Respondent Nos. 1 to 4 & 7 respectively and same has been included in SLP paper books by circulation. No rejoinder affidavit to counter affidavit of respondent No. 5 has been filed, so far.

It is lastly submitted that counsel for the petitioner has on 20.03.2017 filed application for directions alongwith annexures A-C and the same is registered as I.A. No. 2 and being circulated with this office report.

**SLP No. 26337-41/2016**

No one has entered appearance on behalf of all four respondents, so far though served with the notice by registered AD Post.

Service of show cause notice is complete.

**SLP CC.. No. 14697, 21153, 21160, 21168, 21096, 21127, 21226, 21235, 21051 OF 2016**

The present petitions are pending as fresh matters.

**SLP No. 2130 of 2017**

The matter above mentioned was listed before the Hon'ble Court on 16.01.2017, when the Court was pleased to pass the following order:

*"Heard the learned counsel for the petitioner and perused the relevant material.*

*Application for exemption from filing official translation is allowed.*

*Delay condoned.*

*Issue notice.*

*Tag with S.L.P.(C) No.15438 of 2016. "*

Accordingly, show cause notice was issued to all the three respondents on 08.02.2017 through registered AD Post. Respondent nos. 1 and 2 have not been served with the notice and respondent no. 3 have been served with the notice as per

report of the postal authority but no one has entered appearance on behalf of respondent no. 3 so far, though served.

Service is not complete on respondent nos. 1 and 2.

**SLP NOS. 2063, 2064, 2065, 2066, 2068, 2069, OF 2017**

The matters above mentioned were listed before the Hon'ble Court on 16.01.2017, when the Court was pleased to pass the following order:

*"Heard the learned counsel for the petitioners and perused the relevant material.*

*Delay condoned.*

*Exemption from filing O.T. is granted.*

*Issue notice.*

*Tag with Special Leave Petition (Civil) No.15438 of 2016."*

Accordingly, a common show cause notice was issued to all the three common respondents on 03.02.2017 in all the SLPs. All the three common respondents in all the SLPs have not yet been served with the notice as per report of the postal authority.

Service of notice is not complete.

**SLP No. 2066 of 2017**

It is submitted that Mr. Mishra Saurabh, Advocate has on 09.03.2017 filed vakalatnama/appearance on behalf of respondent nos. 1 & 2, but no counter affidavit has been filed by the counsel, so far. Neither A.D. Card nor unserved cover has been received back in respect of respondent no. 3, so far.

Service of notice is not complete on respondent no.3.

**SLP Nos. 2947, 2959, 2960, 2961, 2962 OF 2017**

The matters above mentioned were listed before the Hon'ble Court on 23.01.2017, when the Court was pleased to pass the following order:

Service is complete through Standing Counsel.

It is lastly submitted that all the three respondents in SLP Nos. 2130, 2063, 2064, 2065, 2066, 2068, 2069, 2947, 2959, 2960, 2961, 2962 OF 2017 are common.
