UPON hearing the counsel the Court made the following  
O R D E R

Ld. Advocate-on-record, Mr. Shashibhushan P. Adgaonkar has filed two separate applications seeking intervention alongwith vakalatnama but as per office report the same are defective. It has been submitted by Ld. Advocate, Mr. Anoop Raj that defects in the applications have already been cured on Saturday. Let Registry to verify and update the records.

If defects are found to have been cured, let the applications be processed as per rules, else four weeks' time is granted to cure the defects.

As per office report, respondent No.19 has failed to file counter affidavit, despite the grant of last opportunity. However, Ld. counsel for respondent No.19 has submitted that counter affidavit has been filed yesterday. Registry to verify and update the records. If counter affidavit has been filed, let the same be taken on record, else further opportunity to file the same would stand declined.

Respondent Nos.6, 8, 9, 11 and 12 have failed to file counter affidavit, despite the grant of last opportunity. Hence, further opportunity to file the same is hereby declined.

Ld. Counsel for the petitioner is granted two weeks' time to take fresh steps and to file fresh particulars for service on respondent Nos.15 and 24.

It has been submitted by Ld. Counsel for the petitioner that permission be granted to serve respondent No.15/Tehsildar through the standing counsel for State of Maharashtra. Allowed. Let particulars be furnished within two weeks.

Respondent Nos. 16, 17 and 20 are granted four weeks' time for filing counter affidavit.

Ld. Counsel for the petitioner is granted four weeks' time to take appropriate steps in respect of deceased respondent No.21.

Service on respondent Nos.1 to 5, 7, 10, 13 and 14 has already been deemed to be complete vide order dated 26.9.2025 but none has entered appearance.

Ld.Counsel for the petitioner has not taken appropriate steps, despite the grant of last opportunity with regard to deceased respondent No.31.

Service is complete on the remaining respondents, but none has entered appearance.

Registry to process the matter for listing before the Hon'ble Judge in Chambers due to default in taking appropriate steps for deceased respondent.
