The matters above mentioned have been filed against court's order dated 29.08.2014, 04.10.2013 and 09.04.2013 of the Hon'ble Court of Judicature at Allahabad, Bench at Lucknow in Service Bench No. 1539 of 2001, Review Petition Defective No. 62 of 2014 in Writ Petition(S/B) No. 1539 of 2001 respectively.

It is submitted that there is a delay of 163 days in filing Special Leave Petition in Special Leave Petition (Civil) CC No. 9895 of 2015 and Counsel for the Petitioner has filed an application for condonation of delay to condone the said delay.

Counsel for the Petitioner has filed letter regarding defects notified by the Registry. Copy are included in the Paper Books at page No. 115, 124 and 115 respectively.

It is submitted that Counsel for the Petitioner has on 05.08.2015 filed additional documents in Special Leave Petition(c) No. 14833 of 2015 with application for permission to file the same which is registered as Interlocutory Application No. 3 and same is being circulated for perusal of the Hon'ble Court.
