OFFICE REPORT

It is submitted that Mr. Anjani Kumar Mishra, Advocate, has filed Special Leave Petition on 3.6.2016 against the Judgment and Order dated 10.12.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos.1811, 1602, 1812 to 1817, 1819, 1821 to 1822, 1824 to 1829m 1831 to 1832, 1834 to 1838, 5403 of 2012, 4531,5863, 5866, 5868, 8044/2013, 5243/2013, 9810/2014(O&M) alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased petitioner No. 1 namely Sita Ram in RFA NO. 5863/2013, Petitioner No.1 namely Jai Bhagwan in RFA No. 1834/2012 and Petitioner No.3 namely Hari Om in RFA No. 1834/2012 which is barred by time by 86, 500, 649 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 84, 79, 83, 85, 79, 81 days in filing the SLP (ii) a delay of 77 days in refiling the SLP. There is a total delay of 161, 156, 160, 162, 156, 158 days in filing and refiling the Special Leave Petition

It is further submitted that SLP (C) No.20674/2016 @ CC No. 13398/2016 Entitled ADANI LOGISTICS LTD Versus LAND ACQUISITION COLLECTOR AND ORS arising out of common order was listed before the Hon'ble Court on 25.7.2016 when the Hon'ble Court was directed to issue of notice. The said SLP is pending after notice (Copy of order dated 25.7.2016 is enclosed herewith).

The matter is listed before the Hon'ble Court with this office report.
