"SLP(C) NOS. 22229, 22231, 22232, 22233, 22238, 22239 of 2015

There are two respondents common to all the SLPs. Respondent No.1 is not served. Id. Counsel for the petitioner to take fresh steps within four weeks time. Notice thereafter be issued.

Vakalatnama in respect of respondent no.2 has been filed. Counter affidavit be filed within four weeks time.

Petitioner no.2 in SLP(C) no. 22232/2015 has expired. Application for substituting his legal representatives has been filed. However, since there is a delay in filing the application, application for condonation of delay is still awaited. Be filed within three weeks time. Both applications thereafter be processed before the Hon'ble Judge in Chambers.

SLP(C) NO.23491/2015

Respondent no.1 is yet to be served. Id. Counsel for the petitioner to take fresh steps within four weeks time. Notice thereafter be issued.

Respondent no.2 has to file counter affidavit. Be filed within four weeks time.

List again on 29.1.2016."

It is submitted that Ms. Rachana Srivastava, Advocate has filed vakalatnama/appearance on behalf of respondent No. 1 in all SLPs but has not filed counter affidavit so far. Counsel appearing for respondent No. 2 in all SLPs has not filed counter affidavit so far.
