CC No. 19668/2015:-

It is submitted for the information of the Hon'ble Court that the instant matter has been filed against the Judgment and Order dated 14.03.2012 of the High Court of Delhi at New Delhi in L.A. Appeal No. 464 of 2010 alongwith applications for permission to file SLP, permission to substitute legal representatives of sole petitioner namely Late Sh. Ram Chander (died on 06.07.2010) and condonation of delay in filing application to substitute legal representatives of sole petitioner (barred by time by 1829 days) (regd. as I.A. Nos. 1, 2 & 3 respectively) and the same have been included in SLP paper books. He has also filed an application for condonation of delay in filing SLP barred by time by 1199 days (unregistered) and the same has been included in SLP paper books.

It is further submitted that C.A. No. 1726/2015 arising out of common order was listed before the Hon'ble Court on 18.03.2015 alongwith connected matters when the Court was pleased to allow the same in terms of signed order. Copy of Order dated 18.03.2015 is enclosed herewith.

It is further submitted that counsel for the petitioner was required to file award, letters & notification and exhibits mentioned in the impugned order. In this regard, he has given a letter dated 27.10.2015 and the same is placed at page No. 62 of SLP paper books.

CC No. 20120/2015:-

It is submitted for the information of the Hon'ble Court that the instant matter has been filed against the Judgment and Order dated 14.03.2012 of the High Court of Delhi at New Delhi in L.A. Appeal No. 455 of 2010 alongwith applications for permission to file SLP, permission to substitute legal representatives of sole petitioner namely Late Sh. Madho Prasad (died on 12.03.2012) and condonation of delay in filing application to substitute legal representatives of sole petitioner (barred by time by 1216 days) (regd. as I.A. Nos. 1, 2 & 3 respectively) and the same have been included in SLP paper books. He has also filed an application for condonation of delay in filing SLP barred by time by 1214 days (unregistered) and the same has been included in SLP paper books.

It is further submitted that counsel for the petitioner was required to file award and orders dated 25.08.2004, 04.08.2005, 05.08.2003 and exhibits mentioned in the impugned order. In this regard, he has given a letter dated 26.10.2015 and the same is placed at page No. 61 of SLP paper books.

It is submitted for the information of the Hon'ble Court that the instant matter has been filed against the Judgment

and Order dated 14.03.2012 of the High Court of Delhi at New Delhi in L.A. Appeal No. 471 of 2010 alongwith application for condonation of delay in filing SLP (barred by time by 1231 days) and the same has been included in SLP paper books.

It is further submitted that counsel for the petitioner was required to file notification dated 05.08.2013 & order dated 25.01.2010 and exhibits mentioned in the impugned order. In this regard, he has given a letter dated 29.10.2015 and the same is placed at page No. 45 of SLP paper books.

It is submitted for the information of the Hon'ble Court that the instant matter has been filed against the Judgment and Order dated 14.03.2012 of the High Court of Delhi at New Delhi in L.A. Appeal No. 463 of 2010 alongwith application for condonation of delay in filing SLP (barred by time by 1231 days) and the same has been included in SLP paper books.

It is further submitted that counsel for the petitioner was required to file notification dated 05.08.2013 & Award No. 5/2005-2006 and exhibits mentioned in the impugned order. In this regard, he has given a letter dated 29.10.2015 and the same is placed at page No. 49 of SLP paper books.

It is further submitted that these matters have been tagged together as all are arising out of common followed judgment/common order.
