**OFFICE REPORT**

**SLP(C) Nos. 22229, 22231, 22232, 22233, 22238 & 22239/2015:-**

The matters above mentioned were listed before the Hon'ble Court on 03.08.2015 when the Court was pleased to pass the following Order:-

**"It is submitted by learned counsel for the petitioner that the controversy is covered by the decision rendered on December 11, 2015 in CA No.10982-11033 of 2014.**

**Issue notice on special leave petition as well as on the application for condonation of delay."**

It is submitted that there are 2 respondents in all SLPs (Both respondents are common in all SLPs). Show cause notice to both respondents was issued on 10.08.2015 by regd. A.D. Mr. Ashwani Kumar, Advocate has filed vakalatnama/appearance on behalf of respondent No. 2 in all SLPs but has not filed counter affidavit so far. Neither A.D. card nor unserved cover has been received from respondent No. 1 so far.

It is further submitted that counsel for the petitioner has on 03.08.2015 filed application for substitution to bring on record Lrs. of deceased petitioner No. 2 in SLP(C) No. 22232/2015 but has not filed application for condonation of delay in filing the substitution application. Despite this Registry's letter dated 11.08.2015, he has not done the needful so far.

Service is not complete on respondent No. 1.

**SLP(C) No. 23491/2015:-**

The matter above mentioned was listed before the Hon'ble Court on 14.08.2015 when the Court was pleased to pass the following Order:-

It is submitted that as directed above, show cause notice to both the respondents was issued on 27.08.2015 by regd. A.D. Mr. Ashwani Kumar, Advocate has on 17.09.2015 filed vakalatnama/appearance on behalf of respondent No. 2 but has not filed counter affidavit so far. Nothing has been received from respondent No. 1 so far.

Service is not complete on respondent No. 1 (common in all SLPs) so far.
