**OFFICE REPORT**

The matters above-mentioned were listed before the Hon'ble Court on 11<sup>th</sup> December, 2015, when the Court was pleased to pass the following orders:

**“Heard.**

**Permission to file the special leave petitions is granted.**

**Issue notice in the applications for condonation of delay and also in the special leave petitions.**

**Deletion of respondents No. 5 to 10 and respondents no. 6 to 30 in SLP (CC No. 21359 of 2015), respondents no. 5 to 10 and respondents no. 6 to 30 in SLP (CC No. 21366 of 2015) and respondents no. 5 to 11 and respondents no. 6 to 30 in SLP (CC No (s). 21556-57 of 2015, arising out of W. P. No. 1947 of 2011 and W. P. No. 3089 of 2014, are deleted at the risk of the petitioner.**

**Applications for deletion are allowed and disposed off.”**

Accordingly, show cause notice was issued to all seven Respondents in all the matters through Registered A.D. Post on 28<sup>th</sup> January 2016. Mr. Ravi Prakash Mehrotra, Advocate has on 15<sup>th</sup> February 2016 filed Vakalatnama/ Appearance on behalf of Respondent Nos.1 to 6 (Respondent No.1 to 4 in each SLP) and he has also on 18<sup>th</sup> May 2016 and 5<sup>th</sup> April 2016 filed Counter Affidavit in all the matters on behalf of said Respondents. Copies of the said Counter Affidavit are included in Paper Books.

It is submitted that Mr. M.C. Dhingra, Advocate has on 3<sup>rd</sup> March 2016 filed Vakalatnama/Appearance on behalf of Respondent No.7 (Common Respondent No.5 in SLP (Civil) Nos.35283, 35285 & 35068 of 2015), but he did not file Counter Affidavit.

Thereafter, the Office Report with regard to non-filing of Counter Affidavit by Respondent No.7 was listed before the learned Registrar Court on 01<sup>st</sup> April 2016 and lastly on 29<sup>th</sup> June 2016, when the following orders were passed:

**“Respondent Nos. 1 to 6 have already filed the counter affidavit.**

**The Ld. Counsel for the respondent No.7 has failed to file the counter affidavit within the period stipulated under the rules. Viewed thus, the matter shall be processed for listing before the Hon'ble Court under the rules.”**

It is submitted that Counsel for the Respondent No.7 (Common Respondent No.5 in SLP (Civil) Nos.35283, 35285 & 35068 of 2015) has not filed Counter Affidavit so far.

The matters above-mentioned are listed before the Hon'ble Court with this Office Report.
