Issue notice in the applications for condonation of delay and also in the special leave petitions.

Deletion of respondents No. 5 to 10 and respondents no. 6 to 30 in SLP (CC No. 21359 of 2015), respondents no. 5 to 10 and respondents no. 6 to 30 in SLP (CC No. 21366 of 2015) and respondents no. 5 to 11 and respondents no. 6 to 30 in SLP (CC No (s). 21556-57 of 2015, arising out of W.P. No. 1947 of 2011 and W.P. No. 3089 of 2014, are deleted at the risk of the petitioner.

Applications for deletion are allowed and disposed off.”

Accordingly, show cause notice was issued on 28th January, 2016 to all the 7 respondents by registered A.D. Post in all these matters. Mr. Ravi Prakash Mehrotra, Advocate has on 15th February, 2016 filed Vakalatnama/Appearance on behalf of respondent Nos. 1 to 6 but has not filed Counter Affidavit in the above-mentioned matters so far. Mr. M.C. Dhingra, Advocate has on 3rd March, 2016 filed Vakalatnama/Appearance on behalf of respondent No. 7 but has not filed Counter Affidavit in the above-mentioned matters so far. Service of Notice is complete in all these matters.

It is submitted that respondent Nos. 5 to 10 in S.L.P. (C) No. 35282 of 2015 and 6 to 30 in S.L.P. (C) No. 35283 of 2015 arising out of S.L.P. CC No. 21359 of 2015 and S.L.P. (C) No. 35284 of 2015 arising out of S.L.P. CC No. 21366 of 2015 and in S.L.P. (C) No. 35067-35068 of 2015 arising out of S.L.P. CC Nos. 21556-21557 of 2015 have been deleted from the array of parties at the risk of the petitioner as per Hon'ble Court's order dated 11th December, 2015.
