O R D E R

C.A. No.1456/2012

Respondent no.67 is not yet served for want of spare copies of the petition. Be provided within one weeks time. Notice thereafter be issued.

Certificate of service qua respondent nos. 54 and 55 is still awaited from the High Court concerned. Fresh reminder be issued.

Better particulars of respondent nos. 9,17,18,51,60,41 and 42 have not been provided by the appellant. Be provided within two weeks time. Notices thereafter be issued.
