O R D E R

In SLP(C) No.13850/09 the case has already been listed before the Hon'ble Judge-in-Chamber.

In SLP(C) No.36137-36158/09 Respondent No.7 has filed vakalatnama. Granted three weeks time as last chance for curing the defects in the Vakalatnama.
