OFFICE REPORT

The matters above-mentioned were listed before the Ld. Registrar Court on 21st March 2017, when the following order was passed:

“C. A. No. 9023 of 2011

Await certificate of service of respondents from the High Court and reminder be issued to this effect.

Fresh alternative arrangement notice be issued to the appellant.

C.A. No. 9024 of 2011

Await certificate of service of respondent Nos. 1 to 40, 42 to 53 from the High Court and reminder be issued to this effect.

Opportunity to respondent No. 41 to file counter affidavit has already been declined.

C.A. No. 9026 of 2011

Await certificate of service of respondent Nos. 1 to 20 from the High Court and reminder be issued to this effect.

C.A. No. 11358 of 2011

Opportunity to respondent Nos. 1 to 4 to file counter affidavit has already been declined.

None appears for respondent Nos. 5, 6, 10 to 13, 15 to 18, 20 and 21 despite due service.

Last opportunity for taking fresh steps and furnish the complete address of respondent Nos. 7 to 9, 14 and 19 within two weeks' time.

Notice thereafter be issued.

List again on 19th April, 2017.”

Civil Appeal No. 9023 of 2011

It is submitted that Mr. M.P. Jha, Counsel for the Appellants has expired. A fresh notice for alternative arrangement has already been issued to the appellants on 07.04.2015 but no one has entered appearance so far. An another reminder to the High Court was issued on 29th March, 2017. Certificate of Service in respect of respondent nos.

1 to 24 has not been received so far.

Service is not complete.

Civil Appeal No. 9024 of 2011

It is submitted that there are 53 respondents in the matter. Respondent No. 41 is represented by counsel.

An another reminder was issued to the High Court of Judicature at Bombay on 06th April, 2017. Certificate of Service has not been received so far.

Service is not complete on respondent nos. 1 to 40, 42 to 53.

Civil Appeal No. 9026 of 2011

It is submitted that an another reminder was issued to High Court, Bombay on 06th April, 2017 requesting therein to send certificate of service in respect of respondent nos. 1 to 20. Certificate of Service has not been received so far.

Service is not complete on respondent nos. 1 to 20.

Civil Appeal No. 11358 of 2011

It is submitted that there are 21 respondents in this appeal. Service of Notice of Lodgment of Petition of Appeal is complete on all the respondents except respondent nos. 7 to 9, 14 & 19. Mr. B.K. Prasad, Advocate has not filed Counter Affidavit on behalf of respondent nos. 1 to 4 and last opportunity is declined. Certificate of service has been received from the High Court in respect of respondent nos. 5, 6, 10 to 13, 15 to 18, 20 and 21 but no one has filed Vakalatnama/Appearance on their behalf.

It is further submitted that the counsel for the appellant has not filed fresh and complete address in respect of respondent nos. 7 to 9, 14 and 19 alongwith copies of Petition of Appeal. Hence Notice could not be issued.

Service in respect of Respondent No. 7 to 9, 14 and 19 is not complete.

The matters above-mentioned are listed before the Ld. Registrar Court with this office report.
