CIVIL APPEAL NO.1459 OF 2012

It is submitted that there are 6 respondents. Respondent Nos.1-3 are represented through Mr. B.K.Prasad, Advocate. Certificate of Service has been received in respect of Respondent Nos.4 and 6 but no one has filed vakalatnama/appearance on behalf of the said respondents so far.
