UPON hearing counsel the Court made the following
O R D E R

SLP(C) NO.33137/2009

Legal representative Nos. 1 to 4 of deceased respondent No.1 and
respondent No.2 are granted four weeks' time as final chance for filing

counter affidavit on record.

It appears that on behalf of respondent No.3, State of UP, vakalatnama till date has not been filed. Needful be done by next date. Also counter affidavit be filed by next date.

SLP(C) NO.3931/2011

In all there are three respondents.

Fresh notice be issued to respondent Nos. 1 to 3 through the concerned District Court besides the usual postal mode. The ld. Counsel for the petitioner has undertaken to take necessary steps accordingly.

SLP(C) NO.3932/2011

In all there are four respondents out of which respondent No.2, who despite being served has not appeared nor any steps taken on his behalf.

Respondent nos. 1,3 and 4 are yet to be served. Fresh notices be issued to the concerned District Court besides the usual postal mode.

SLP(C) NO.5501 AND 5607 OF 2011

As per office report, respondents in these two matters are reported to be duly served and represented through the ld. Counsels. However, the report is silent about the further status of these two matters viz, whether counter affidavit is to be filed or has been filed. Respondent No.4 despite being duly served has not appeared.

Fresh notice be issued to respondent No.5 through the concerned District Court besides the usual postal mode. Respondent No.5 being State of UP be served through its standing counsel.

It is pertinent to note that in all these batch of matters, office report seems to be confusing and ambiguous as it runs contrary to what is shown in the cause list. Office to prepare a complete and proper report so as to facilitate this Court to pass further necessary appropriate orders. Duly represented respondents in all these batch of matters are granted four weeks' time as final chance for filing counter affidavit.

It would not be out of place to mention here that there is a discrepancy between the cause list and the office report as some of the matters shown in the office report are not reflected in the cause list which has created a confusion as regards status of the matters shown in the office report. Office should be careful while preparing office report as well
