Ms. Shubhra Rai, Ld. Advocate has appeared on behalf of the respondent Nos. 1 and 2. She seeks and is given four weeks time to file the vakalatnama and the counter affidavit.

SLP(C) No. 8301/2014

Ms. Shubhra Rai, Ld. Advocate has appeared on behalf of the respondent No.1. She seeks and is given four weeks time to file the vakalatnama and the counter affidavit.

The learned counsel for the respondent No.2 has filed the vakalatnama which is defective. The learned counsel is directed to cure the defects within a period of four weeks and to file the counter affidavit within the same period.
